

REDCAR AND CLEVELAND BOROUGH COUNCIL (OFF STREET PARKING PLACES)CONSOLIDATION ORDER 2003 (AMENDMENT)ORDER NO 4 2023

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 ("the Act") the effect of which will be to amend the Redcar and Cleveland Borough Council (Off Street Parking Places) Consolidation Order 2003("the Order") as follows:-

- a. By changing the hours of operation of the Redcar Off Street Car park Coast Road Redcar and Marske Off Street Car Park Coast Road Marske from 08:00-22:00 hours with no overnight parking to 24 hours a day maximum stay of 4 hours permitted no return within 4 hours. No charges will apply.
- b. By adding the following carparks into the Order and requiring vehicles to park in bays marked for their class of vehicle, no limit on the time for which vehicles may wait, no charges apply: North Road Car Park Loftus, Handale Car Park Loftus, High Street Skelton Car Park, West Street Eston Car Park.

THE REDCAR AND CLEVELAND BOROUGH COUNCIL (OFF STREET PARKING PLACES) (CONSOLIDATION) ORDER 2003 AMENDMENT ORDER No 4 2023

The Council of the Borough of Redcar and Cleveland (hereinafter called "the Council") in exercise of its powers under Section 35(1) and (3) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order shall come into operation on the day of 202 and may be cited as the Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation) Order 2003 Amendment Order No 4 2023.
- 2. The Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation)Order 2003 ("the Order") is hereby amended as follows:
 - i. By deleting from Column 6 of the Off Street Car Park Schedule ("the Schedule") the maximum period for which vehicles may wait in respect of Redcar Off Street Car Park Coast Road Redcar and Marske Off Street Car Park Coast Road Marske the words 8am to 10pm no limit and No Waiting 10pm to 8am.
 - ii. By inserting into Column 6 of the Schedule the maximum period for which vehicles may wait in respect of Redcar Off Street Car Park Coast Road Redcar and Marske Off Street Car Park Coast Road Marske the words 4 hours no return within 4 hours
 - iii. By inserting the following into the Off Street Car Parks Schedule Loftus Car Parks

STATEMENT OF REASONS

The car parks at Coast Road are currently unrestricted, in order to regulate parking and ensure turnover of vehicles it is proposed to implement a 4-hour maximum stay, no return within 4 hours. The restriction will help prevent vehicles from parking up for long periods and overnight whilst maintaining parking spaces for users wishing to access the beach, promenade, and surrounding area. As part of the proposal the height restriction bars will be removed as these are in a very poor state of repair. The height restriction bars have not been in operation for several years as these were creating issues for genuine users with larger vehicles wishing to access the car park.

As part of the amendment, it is proposed to add North Road Loftus, Handale, Loftus, High Street Skelton and West Street Eston to the off street parking order (TRO). The car parks will remain free of charge however adding them to the off-street order will allow the authority to regulate the use of the car parks and enforce where necessary in respect of misuse of the designated bays (Disabled and EV bays).
