1. For any event held at the premises and under the authority of a Premises License, an event manual for the event shall be produced and sent to all responsible authorities at least 28 days prior to the event taking place. Within the event manual a site map will show the exact locations of where licensable activities will take place.
2. Licensable activity will only be permitted within a secure fenced area that may be sited anywhere within the highlighted area on the map provided
3. The DPS will ensure all license conditions are met along with current legislation
4. The DPS will ensure all staff are trained in the sale of alcohol and their responsibilities to uphold the licensing objectives and premise license conditions, training will be carried out at least once each year and records will be kept for 12 months.
5. The site will be ready for inspection by the council (should they wish too) on the morning of the first event
6. Local residents shall be informed in advance of any events taking place
7. The license holder shall have regard to advice contained within The Purple Guide.
8. portaloos will be provided outside of the event space for queuing members of the public
9. Challenge 25 posters will be displayed predominantly around the venue.
10. A set of house rules will be displayed at the main entrance gate, advising customers of the events expectations (searches are in operation, CCTV is in operation, challenge 25 etc)
11. Bins will be situated outside the event footprint for the benefit of queuing guests
12. All customers entering the site will be identifiable via a tamper proof wrist band
13. The organiser is to be responsible for collection and disposal of all waste from the event.

b) The prevention of crime and disorder

1. The premise will be equipped with a digital cctv system, which will capture anyone entering the site via the main entrance . The system shall be in operation whenever the site is open to the public
2. CCTV footage will be retained for 31 days
3. A drugs policy shall be in place for all events operating under the premise license
4. A search policy shall be in place for all events operating under the premise license
5. Licensable activity shall only take place within the fence line.
6. Appropriate levels of competent security personnel will be employed throughout the events. Numbers will determined by analysing various factors including age, crowd demographics, and the type of event been produced.
7. All SIA licensed door supervisors shall wear distinctive clothing or insignia to clearly identify them as door supervisors.
8. Security staff and the event management will actively monitor crowd movement in the licensed area during the whole of each licensed event in accordance with the Crowd Management Plan.
9. A refusal register shall be kept on site and completed as and when required

c) Public safety

1. An event manual will be produced and supplied to the council with a description of the event with assumed audience numbers and various measures that will be in place to ensure public safety including the use of any special effects. Special effects may include, lasers, naked flames, pyrotechnics, projectiles or fireworks
3. Licensable activity shall only take place within the fence line.
4. Appropriate levels of competent security personnel will be employed throughout the events.
5. Appropriate levels of medics will be employed throughout the events. The purple guide will be used to determine the appropriate level of cover needed
6. Fire fighting equipment will be situated around the site
7. Risk assessments will be included within the event manual
8. The premise will operate a no glass policy in the main public areas. Glass bottles such as wine and champagne will be allowed in the VIP area only.
9. Drinking water (tap water) will be available to patrons upon request
10. The premise license holder shall notify all relevant bodies of proposed events via the SAG. The relevant bodies will include, police, fire, ambulance.
11. The event space shall have several emergency exits that are clearly identifiable and unobstructed. The amount width and location will be decided using guidance within the purple guide or a similar document, and be documented in the EMP

d) The prevention of public nuisance

1. A noise management plan will form part of the event manual
3. A maximum of 65dB(A) will be the prescribed limit at the nearest noise sensitive premise. These premises are located: Newcomen Terrace, Marina Avenue, High Street West
4. Only 6 events days with licensable activities will be permitted each year
5. A maximum of 3 event days will be allowed in 1 calendar week
6. The organiser shall ensure that the sound supplier and all individual sound engineers are informed of the sound control limits.
7. The premises license holder shall appoint a nominated person to liaise on all matters relating to noise prior to, and during the event, and to carry out the noise monitoring during the event.
8. The exact times of all sound checks shall be submitted to and approved in writing by the Licensing Authority no later than 21 working days before an event commences.
9. Rehearsals and sound checks are only permitted between 10:00hrs to 19:00hrs.
10. Residents, shall be informed in writing no later than 21 working days before an event, of the exact times sound checks will be undertaken, exact times the event will operate, and provide a contact name and telephone number in the event of a complaint.
11. During live and recorded music, a logging sound level meter capable of octave frequency analysis shall be used to monitor the Music Noise Level (MNL) 1 meter from the boundary of noise sensitive premises.
12. The results of this monitoring shall be provided to the licensing authority within 10 working days following any event.
13. Measurements of MNL shall be undertaken hourly using a 15-minute LAeq.
14. The MNL shall not exceed the maximum agreed level over a 15-minute period at the boundaries of the specified locations
15. A written record of noise monitoring shall be kept detailing the date, time, duration, location, weather conditions, wind speed, MNL measured and any action taken to reduce MNL. These results shall be made available to all times upon request to an officer of the local authority.
16. Any complaints received shall be recorded and reported within the noise report submitted to the local council
17. A contact number shall be circulated to local residents to enable them to raise complaints should the need arise

e) The protection of children from harm

1. All events will be 18+ unless advertised otherwise
2. Where it is felt appropriate (ie bands & family events) some events may be classed as 16+ unless accompanied by an adult
3. Should an event be deemed suitable for a younger audience, safe guarding policies and procedures will be added to the event manual for consideration by the Safety Advisory Group
4. A challenge 25 policy will be in place when alcohol is being sold

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. In terms of specific **regulated entertainments** please note that:

- **Plays:** no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- **Films:** no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- **Indoor sporting events:** no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- **Boxing or Wrestling Entertainment:** no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- **Live music:** no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- **Recorded Music:** no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
