

**REDCAR AND CLEVELAND BOROUGH COUNCIL
(ESTON, NORMANBY, ORMESBY, TEESVILLE AND NUNTHORPE) (WAITING AND
LOADING AND PARKING PLACES)
(CONSOLIDATION) (AMENDMENT) ORDER (NO.1) 2024**

The Council of the Borough of Redcar and Cleveland (hereinafter referred to as "the Council") under Sections 1, 2, 4, 32, 35, 45, 47, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order.

1. This Order shall come into operation on the 8th day of July 2024, and may be cited as the Redcar and Cleveland Borough Council (Eston, Normanby, Ormesby, Teesville & Nunthorpe) (Waiting, Loading and Parking Places) (Consolidation) (Amendment) Order (No 1) 2024
2. The Redcar and Cleveland Borough Council (Eston, Normanby, Ormesby, Teesville & Nunthorpe) (Waiting and Loading and Parking Places) (Consolidation) Order 2003 is hereby amended by inserting the following Eston, Normanby, Ormesby, Teesville & Nunthorpe Schedule 1 No waiting at any time:-

California Road, Eston

- (i) the north-east side, from a point 10 metres south-east of its junction with High Street, Eston, for a distance of 37 metres in a south easterly direction.
- (ii) the south-west side, from its junction with Guisborough Street, for a distance of 7 metres in a north westerly direction and for a distance of 7 metres in a south easterly direction.

Guisborough Street, Eston

- (i) both sides, from its junction with California Road, for a distance of 10 metres in a south-westerly direction.

High Street, Eston

- (i) the north-west side, from its junction with California Road, to the property boundary of 228 & 230 High Street, Eston.
- (ii) the north-west side, from a point 28 metres north-east of its junction with Lodge Farm Road, to its junction with California Road.
- (iii) the south-east side, from its junction with Lodge Farm Road, to a point 5 metres west of its junction with California Road.
- (iv) the south-east side, from a point 5 metres north-east of its junction with California Road, to the property boundary of 228 & 230 High Street, Eston.
