

## REDCAR AND CLEVELAND BOROUGH COUNCIL (OFF STREET PARKING PLACES)CONSOLIDATION ORDER 2003 (AMENDMENT)ORDER NO 1 2024

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 ("the Act") the effect of which will be to amend the Redcar and Cleveland Borough Council (Off Street Parking Places) Consolidation Order 2003("the Order") as follows:-

- a. By introducing 1 hour free parking in Fountain Street East Car Park Guisborough (including the Coach Parking Area), only 1 free stay per calendar day with charges for 2 hours £1.80 and £2.40 for each additional hour thereafter.
- b. By deleting Belmont House Car Park from the Order.

## STATEMENT OF REASONS

Following the end of the TVCA funding to provide 2 hours free parking in council short stay car parks and on street locations, parking charges were re-introduced in January 2024.

It is now proposed to amend the off-street parking order to provide 1-hour free parking at Fountain Street East Car Park and Fountain Street East Coach Park to provide an element of additional free parking provision in Guisborough.

It is also proposed to remove Belmont House car park from the off-street parking order as this is no longer a council car park.

The Council of the Borough of Redcar and Cleveland (hereinafter called "the Council") in exercise of its powers under Section 35(1) and (3) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order :-

- 1. This Order shall come into operation on the day of 202 and may be cited as the Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation) Amendment Order No 1 2024.
- 2. The Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation)Order 2003 ("the Order") is hereby amended as follows :-
  - (i) By deleting the Scale of Charges specified in Column 7 of the Schedule in respect of Fountain Street East Car Park (including the Coach Parking area )
  - (ii) By inserting the following Scale of Charges in Column 7 of the Schedule in respect of Fountain Street East Car Park (including the Coach Parking Area) 1 hour free of charge only 1 free ticket per calendar day £1.80 2 hours
    £2.40 each additional hour thereafter
  - (iii) By deleting Belmont House Car Park and all references thereto from the Order.
